Representatives from Talen Energy and IBEW Local 1600 met yesterday afternoon regarding upcoming bargaining unit reductions. In accordance with Article X of the labor agreement between Talen Energy and IBEW Local 1600, the Company identifies the job classifications and locations of the excess positions and notifies IBEW Local 1600 of its intent. The Union and the Company then have 10 working days to correctly identify the displaced employees based on lowest IBEW Local 1600 seniority within the job classification at the work location.

There are a total of 131 excess positions between Montour SES, Brunner Island SES, Susquehanna SES, and Susquehanna's Allentown office. Following are the numbers of excess positions identified by the Company and submitted to IBEW Local 1600 leadership yesterday:

No later than August 2, 2016, IBEW Local 1600 will notify the Company of the names of the displaced employees. The identified displaced employees will then be notified by their supervisor of their displacement. All displaced employees will then be scheduled to attend a meeting at their work location whereby members of Talen and IBEW Local 1600 will review the Article X process with the displaced employees. These meetings will help employees better understand how the process will work, what their options for selecting other positions may be, and have an opportunity to ask questions relative to the process.

We understand this is a stressful time for employees, but we ask that employees have patience as the Company and the Union work through this process, to remain focused on your work, not be distracted, and to work safely.
