### AFFIDAVIT of PROBABLE CAUSE

Your affiant is a member of the Pennsylvania State Police currently assigned to the Criminal Investigation Unit at the Troop N, Bloomsburg Station. I have been a member of the Pennsylvania State Police since June 2006 and a Criminal Investigator since October 2013.

The defendant, Linda Tarlecki, was employed with the Township of Conyngham in Columbia County, Pennsylvania, as their Secretary and Treasurer, as well as, an elected Township Supervisor. She had been employed in these capacities since approximately 2006. Tarlecki's responsibilities at the township were to manage day to day functions, effectively organize and minute meetings, maintain records to include paying creditors and completing payroll for township employees.

In November 2017, John McGee and Martin Wolfe were elected to the Conyngham Township Board of Supervisors as the results of the General Election. On January 1, 2018, McGee and Wolfe officially took over office.

Once the newly appointed supervisors began their term they were unable to locate financial records within the township's computers or building. They were unable to account for financial documents to include; bank statements, ledgers, receipts or invoices relative to the day to day operations of the township.

Conyngham Township Supervisors obtained banking records from FNB Bank. After reviewing the bank statements, they discovered many improprieties that brought concern within both the General Fund Account and Payroll Account. The banking records were turned over to the state police for further investigation.

After reviewing the banking records from FNB Bank, it was discovered that in 2013, Tarlecki wrote nine (9) unauthorized checks to herself from the Payroll Account totaling \$7,365.53 and forty-nine (49) unauthorized checks to herself from the General Fund Account totaling \$13,710.51.

In 2014, it was discovered that Tarlecki had written herself twenty-one (21) unauthorized checks from the Payroll Account totaling \$16,699.30 and twenty-three (23) unauthorized checks to herself from the General Fund Account totaling \$5,264.93.





In 2015, Tarlecki wrote thirty-six (36) unauthorized checks to herself from the Payroll Account totaling \$30,954.10 and nineteen (19) unauthorized checks to herself from the General Fund Account totaling \$5,238.29.


In 2016, it was discovered Tarlecki had written herself nineteen (19) unauthorized checks from the Payroll Account totaling \$19,735.98 and twenty-eight (28) unauthorized checks to herself from the General Fund Account totaling \$18,867.08.

In 2017, Tarlecki wrote eighteen (18) unauthorized checks to herself from the Payroll Account totaling \$10,984.36 and sixty-nine (69) unauthorized checks to herself from the General Fund Account totaling \$52,008.62.

This information was uncovered after reviewing the financial statements to include cashed checks from both the Payroll Account and General Account provided by the township supervisors after they obtained them from FNB Bank. From the 2013 – 2017, Tarlecki had issued herself fraudulent checks from both the Payroll Account and General Account totaling **\$180,828.60**.

In addition, Conyngham Township also incurred penalties for late fees/non-payments totaling \$18,562.32 from January 2013 through December 2017 by the Internal Revenue Service.

I verify the facts set forth in this complaint are true and correct to the best of my knowledge and respectfully request that a warrant be issued for the defendant, Linda Tarlecki.
