

AFFIDAVIT of PROBABLE CAUSE

Your Affiant is Trooper Ryan GOLLA of the Pennsylvania State Police, Troop N - Criminal Investigation Unit.

Your Co-Affiant is Corporal Brian NOLL of the Pennsylvania State Police. Corporal NOLL is assigned as the Troop N Criminal Investigation Assessment Officer.

On Sunday, 06/22/2025, at approximately 1530 hours, the Pennsylvania State Police Bloomsburg barracks was contacted by Columbia County District Attorney Daniel LYNN. District Attorney LYNN advised that Hemlock Township Police Department was currently investigating a missing person incident. DA LYNN advised that during his conversation with Sgt. Scott TRAUGH, with the Hemlock Township Police Department, he requested that the incident be reassigned to the Pennsylvania State Police. DA LYNN advised Cpl. Kurtis KILLIAN that the incident revolved around the disappearance of Katlyn Marie HARP. HARP was last seen by her husband Vincent HARP inside their residence on 06/19/2025 between 2100 and 2300 hours. Vincent HARP related that when he awoke at approximately 0500 hours Katlyn HARP was not in the residence and was unable to be located.

Cpl. KILLIAN contacted Sgt. Michael BOROSH the Officer of the Day. A Troop N- Major Case Team was established under the direction of Troop N – Criminal Investigation Unit - Sgt. Eric SHELLENBERGER. The members of the Major Case Team assembled at PSP Bloomsburg at approximately 1745 hours.

Sgt. Scott TRAUGH and Cpl. Charles DIETTERICK arrived at PSP Bloomsburg at approximately 1800 hours and began briefing members of the incident.

On Friday, 06/20/2025, at approximately 1608 hours, Patrolman Bradley SHARROW received a phone call from Heather LANE requesting a welfare check on her sister Katlyn HARP. LANE informed Hemlock Township Police Department that Katlyn HARP resides at 20 Fairview Drive in Hemlock Township with her husband Vincent HARP. Ptlm. SHARROW was informed that LANE last spoke with her sister at 1844 hours on 06/19/2025. LANE related





that she hears from her sister every day, and it is not like her to go without communication. LANE informed Ptlm. SHARROW that she has had conversation with Vincent HARP, and he informed LANE that they had argued after dinner the night prior. LANE informed Ptlm. Sharrow that she has Life360 on Katlyn's phone and Life360 has not updated since the night prior.

A regional message was sent through East Central Communications to all local Police Department to be on the lookout for Katlyn HARP by Hemlock Township Police Department on 06/20/2025.

Between 06/20/2025 and 06/22/2025 the Hemlock Township Police Department utilized investigative efforts to locate Katlyn HARP. These efforts included speaking with family members, consulting local law enforcement departments that have jurisdiction over properties the HARPS are known to frequent, and attempting to contact the treatment center Katlyn HARP goes to get methadone treatment. Through investigation it was learned that Katlyn HARP has had no communication through any messaging applications, phone calls, or text messages since 06/19/2025. Vincent HARP provided Hemlock Township Police Department with screenshots of text messages that were sent from his phone to Katlyn's phone. Vincent HARP has also provided statements to Hemlock Township Police that he has had no contact with Katlyn HARP since 06/19/2025 between 2100 and 2300 hours. Vincent HARP also stated that Katlyn HARP has not returned to the residence.

On 06/22/2025, The Pennsylvania State Police Troop N Cellular Analysis Technician, Trooper John P. LUTCHKO completed an exigency request for Katlyn HARP's Verizon Wireless phone records. Data from the historical records is consistent with Katlyn HARP's device being in the area of 20 Fairview Drive, Hemlock Township, Columbia County on 06/19/2025 until approximately 2125 hours.

A regional message was sent through East Central Communications to all local Police Department to be on the lookout for Katlyn HARP by Hemlock Township Police Department on 06/20/2025.

On 06/23/25 at 0003 hours, Corporal Brian Noll and Trooper Ryan GOLLA interviewed Vincent HARP at the Pennsylvania State Police Bloomsburg Barracks.

Through the course of the interview, it was revealed that Vincent HARP was in constant communication with Katlyn via his cellular phone in the days and hours leading up to her disappearance. Vincent HARP related he received a message from Katlyn in the early morning hours of 06/19/25, after her Life360 application was no longer active. Throughout the interview, Vincent HARP was inconsistent with his movements before, during and after Katlyn's disappearance. These discrepancies include stating that he had talked to his counselor then changing his story to say he did not speak with the counselor the morning of June 20th. He initially related that he had his phone with him Friday morning, then changed his account to say that he left his phone at the office. Vincent HARP related that he made numerous texts and calls to the Victim. Additionally, he omitted locations he traveled and failed to report interactions with Katlyn.

Through the course of this investigation, it was learned that Vincent HARP appeared at the Sunoco gas station located at 100 Montour Street, Danville, PA 17821, on 06/20/2025, at approximately 1741 hours. During his appearance at the Sunoco location HARP entered the gas station. After walking around the station, he approached the cashier and asked if the store sold gloves. The cashier informed him they did not. HARP then asked the cashier if he could have a pair from the store. HARP related that he only needed one pair. HARP is then observed on video placing the gloves in his pocket and then walking back out to his silver in color Chevrolet Silverado parked at a gas pump before leaving his location. This is significant to this investigation as this identifies one of the vehicles HARP utilized to travel to a location of interest in the disappearance of Katlyn HARP. This location of interest is located on Shade Mountain Road, a mountain road approximately 15 miles in length that is not heavily traveled. During his interviews Vincent HARP was unable to articulate a reason for being on the stretch of roadway. It is known that Vincent HARP was stuck on this

roadway in a 2007 GMC Yukon on the morning of 06/20/2025 between 1000-1100 hours. This caused both Vincent HARP and the vehicle to be covered in mud. Through examination of his cellular device, he returns to this location on 06/20/2025 between approximately 1820 and 1850 hours. During examination of this heavily wooded desolate location evidence of drag marks into and out of the wooded area were observed. These drag marks appear to originate from the location that Vincent HARP's phone communicated with the network.

On 06/25/25 a recently sold 2022 Kawasaki UTV was brought to PSP Bloomsburg. Members of PSP Troop N, Forensic Service Unit conducted a field test that showed a presumptive positive for human blood. The test area was the driver and passenger seat of the UTV. This UTV was known to be utilized by Vincent HARP as recent as 06/18/2025 via trail camera footage provided by a neighbor. This UTV was sold by Vincent HARP on 06/24/2025.

Through further examination of Vincent HARP'S cellular data, his path of travel was mapped on the evening of 06/20/25 as he returned from Shade Mountain Road to his residence. The Middleburg Police Department provided video surveillance depicting Vincent HARP'S Chevrolet Silverado passing their station located at 13 N Main Street, Middleburg at 1850 hours, consistent with his cellular phone activity. The video clearly depicts a large box in the bed of the vehicle.

Surveillance was also obtained from the VFW located at 1258 Millville Road, Bloomsburg. On 06/20/25, at 1740 hours, Vincent HARP'S Chevrolet Silverado can be seen passing this location also consistent with his cellular activity. The video clearly depicts a large green box in the bed of the vehicle.

On 06/29/25, at approximately 1229 hours, PSP Bloomsburg received a call from the Victim's sister, Heather LANE notifying that she and a search party believed they had located Katlyn at 86 Harp Lane, Montour Township, Columbia County. This property was formerly owned by Vincent HARP. Consent was obtained from the current homeowner and investigators and other emergency personnel responded to the area. A large green metal box, consistent with surveillance viewed of the box in the bed of HARP'S Silverado, was discovered along the mountainside north of Vincent HARP'S former property. The box had a strong odor of decomposition emitting from it. The box was retrieved from the mountainside approximately 180 yards from the edge of the cliff. The box lid was locked with a key Masterlock. Upon cutting the lock and opening the box, human remains were discovered. Katlyn HARP was identified via a tattoo as the human remains.

Further examination of Vincent HARP'S cellular records reveal his phone was in the area on 06/21/25, at 1030 hours, passing the dump site area on Route 42. At approximately 1808 hours his phone was on Hollow Road just west of Harp Lane.

Based on the aforementioned facts and circumstances, your Affiants respectfully request a warrant of arrest be issued for Vincent HARP to answer for the charges set forth.
